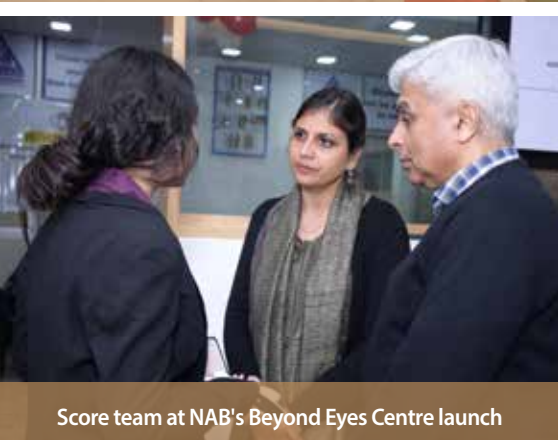

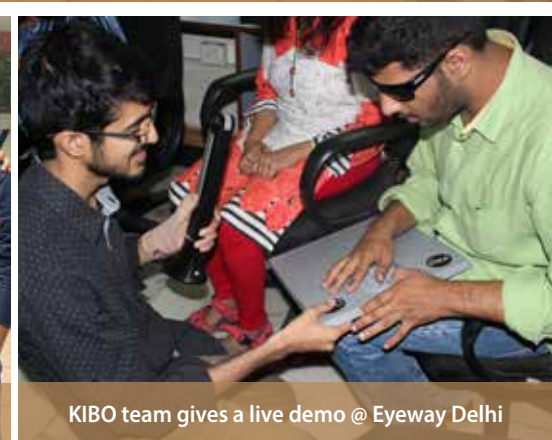

CEO'S STATEMENT



As the financial year 2019-20 drew to a close, our lives were hit by a global pandemic. Covid-19 forced most organizations to close their offices and start operating from home even before the Indian government announced a nationwide lockdown. Our team started remote operations from mid-March. Given that a lot of our employees are visually impaired, we faced initial hiccups with regards to technology, internet etc. But the disruption of routines soon led to innovation and a new normal emerged. Like most others, we also improvised only to realise the benefits of what we hadn't explored earlier. But the havoc caused by the virus and the lockdown left the disabled community helpless vis-à-vis food, medicines and other daily supplies. Our Helpdesk counselors got down to firefighting and soon we created a small army of volunteers to ensure that visually impaired callers received rations and basic monetary help.

As we took calls from across India, we witnessed how some blind people had money in their bank accounts but were simply unable to use it due to physical or digital inaccessibility. The inability to withdraw their own money left them dependent on individual donors for food supplies. With a new virtual universe defining the post-Covid era, it's important that the on ground implementation is done keeping in mind the needs of persons with vision impairment. Digital solutions are not always inclusive. For instance, blind people face issues of access with touch screen devices, CAPTCHA, certain websites and mobile apps. These can be rectified if the global accessibility guidelines are adhered to, by developers and service providers.

Education, employment and entertainment have essentially moved online. Traditional jobs have been hit. A lot of visually impaired people in places like Mumbai, Chennai and Delhi earned their livelihood as masseurs or hawkers. The physically distanced world has no room for such jobs now. But the good news is that blind people with access to devices and the internet are able to participate in all things mainstream. New possibilities of training and employment are being explored. The physical barriers that prevented them from going to school or an office, have disappeared. In the post-Covid world, we need awareness and advocacy drives to make sure that 63 million visually impaired people are not sidelined. Score Foundation is committed to sensitizing the society towards building an inclusive environment where the blind population can study, work or socially engage using the digital medium.

This is a great opportunity to mainstream people with vision impairment because technology promises to provide access to education, financial services, governance and employment. The pandemic may have imposed restrictions but at the same time, it has also given us a chance to look at things afresh.

STRENGTHENING THE EYEWAY NETWORK TO IMPACT LIVES

Eyeway was launched with the prime objective of empowering persons with low vision and blindness via sharing information, counselling them on possibilities and potential of life with blindness as well as advocating for their equal rights. In the past years, we have widened our network to reach several thousand blind citizens across India. We continue to work hard towards strengthening our network of NGOs so that every blind person in this country has easy access to solutions and services.

In the past couple of years, we have faced a consistent challenge with seeking new partnerships and partner organizations driving the project independently in their respective locations. Victoria Memorial School for the Blind happens to be an exception, as they have taken the Helpdesk activities forward at a steady pace since its launch. As for other NGO partners, we still need to transfer ownership so that the project can function in a decentralized manner. With each new partner addition, our capacity to respond to issues facing blind citizens in the respective location and language increases.

We would like to acknowledge our funding partners, The Hans Foundation, ESSEL Foundation, and Cipla Foundation who have helped us translate our vision into reality.

The idea behind Eyeway, of bringing together organizations, joining hands and initiating change collectively is a novel phenomenon. We are exploring an uncharted territory hence we have to constantly improvise our plan to suit the situation. Mapping the entire country with a helpline service like Eyeway is our end term objective but given the response of partner NGOs, our growth has been slower than anticipated.

In the exercise to explore partnerships in every state we have entered into long term relationships with both individuals and organizations who share common beliefs. We have also impacted thousands of lives, guiding and steering them towards a hopeful future.

Garnering support through crowdfunding

In the last financial year, Score team once again explored different crowdfunding platforms to gather support and spread awareness about our project. We used channels like the Airtel Delhi Half Marathon (ADHM) 2019 and Global Giving to reach out to a new donor base seeking contributions to accomplish our objectives. We would like to extend our sincere gratitude to all those who donated towards Project Eyeway through these channels. And of course a heartfelt thanks to all our ADHM runners!

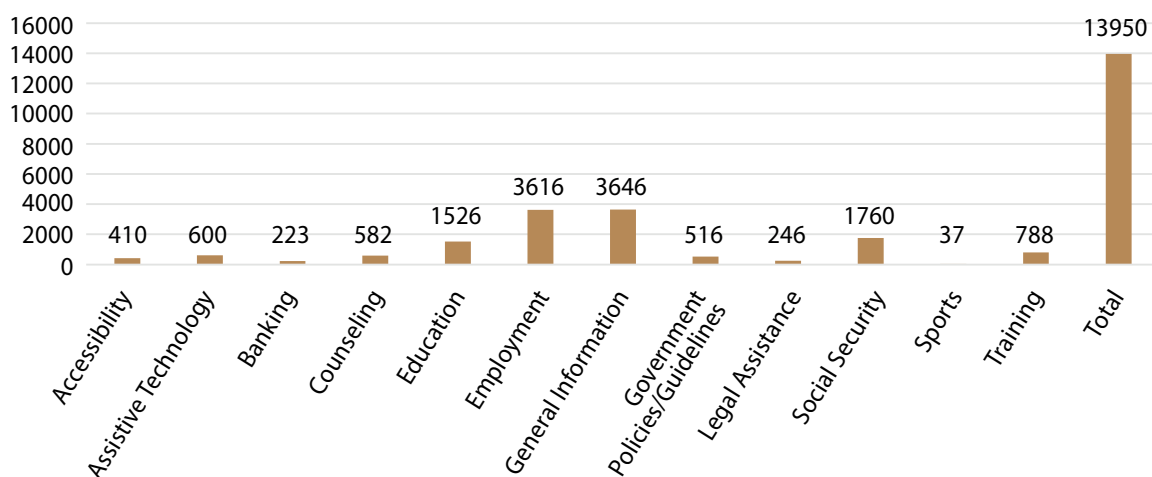

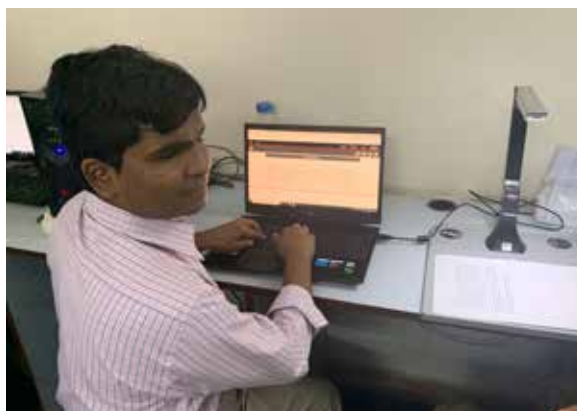
PAVING WAY FOR A BETTER TOMORROW: EYEWAY NATIONAL HELPDESK

Since its transition into a national toll free helpline in December 2015, Eyeway Helpdesk has transformed thousands of lives through our regular interaction and close counselling with callers. Our call flow has seen a consistent rise in numbers with Helpdesk counsellors across locations answering around 1200 calls in a month. The past one year recorded a total of **13950** calls from all over India.

Eyeway consistently responds to queries pertaining to banking issues, scribes, disability certificates, assistive technology, education, career options etc. These resonate the larger issues faced by the visually impaired citizens of the country. Authorities like Banks, Government Offices, Schools and Colleges seem to be unaware of the provisions and rules of the law that allow blind people to participate on an equal footing with their able counterparts. In continuing to operate with their own limited knowledge and personal bias, they tend to deny people with visual impairment their due right to independence and dignity. Eyeway continually strives to bridge this gap through knowledge-sharing and advocacy.



Our Helpdesk team through their systematic guidance, counselling and information dissemination continue to alter mindsets of persons with vision impairment as well as their associated community. Here's a glimpse into some of the lives we touched in the past year.

Seeking help to pursue further education



Shahid Dar, a 22-year-old resident of Bandipore district in Jammu and Kashmir lost 30% of his eyesight to a congenital eye disorder and the rest to an accident at the age of 3. His parents showed no interest in educating him and provided very little support. His brother was more supportive and enrolled him at a local school where he unfortunately had to face physical and emotional abuse. Due to lack of family support, Shahid was forced to discontinue his studies after Class 12. A few years later, in a workshop organised by the HELP Foundation, he came to know about Eyeway.

Shahid sought information on institutes that provide BA courses in Kashmir and how he could pursue graduation. Having received proper counselling and adequate information, Shahid was able to enroll in a Bachelors program in his district. In college he is perceived as a person with calibre, and not someone limited by vision impairment.

Accessibility challenge at workplace

32-year-old **Akshaya Panda** is a visually impaired person from Berhampur, Odisha. He completed his Masters in Social Work from Tata Institute of Social Sciences (TISS). Following this, he was placed as an Executive Trainee in Satluj Jal Vidyut Nigam Ltd (SJVN), Shimla and was later promoted to the role of an Assistant Manager. His job required him to read and sign important documents. But this proved difficult as the printed word is not accessible to a person with vision impairment. When he got in touch with the Eyeway Helpdesk, our counselor informed him about the accessibility provisions compiled under the sections 40 – 44 of the RPWD Act 2016. With this, he wrote an application to the SJVN management. They recognized his need and assigned an employee to assist him until they arranged for the appropriate technology solution for him to function independently.



Charting out his own course



22-year-old **Ujjwal Kumar** lives in Sasaram, Bihar. He struggled to complete his education after he lost his eye sight at the age of twelve. He called Eyeway to find out about coaching centres and study material that would help him prepare for his UPSC exam. Our counselor shared all the details and encouraged Ujjwal to use assistive technology like screen reader, smartphone, daisy player etc. He took Eyeway's advice and prepared hard but unfortunately he didn't clear the exam. That's when he opted for an alternate career and set up his own coaching centre to help other UPSC aspirants. With the help of technology, he could easily deliver tuitions. This new business has made him financially independent.

Empowering through meaningful interventions

A resident of Gadag district of Karnataka, **Shobha Patil** began losing her eyesight at the age of six. She pursued her education despite all difficulties. Turning 31, she called the Eyeway Helpdesk in the hope of gaining financial independence. Our counselor advised her to move to Bangalore and enroll for a training programme that would benefit her greatly. She was keen but her family was unsure of sending her away all by herself. The trainers at Enable India along with the Eyeway counselor convinced them, citing examples of numerous visually impaired women who worked and lived independently. After availing the competitive exams training, Shobha became confident of faring well in her tests and fulfilling her ambitions.



Sharing his blessings



44-year-old **Rajesh Borle** was born blind in Akola, Maharashtra. With support from his family, he managed to do well and secure a job as a special educator. Learning about the challenges faced by a few blind students, he decided to extend all possible help. He lodged eight of the students in his home and inquired about scholarship schemes from Eyeway to fund their education. He also checked on the latest assistive technology that could aid them in reading and writing. Since his own income was insufficient to meet their needs, Rajesh invested in the stock market to earn a few extra bucks. Heartened by his initiative, Eyeway put him in touch with a group of visually impaired investors for expert advice. Contrary to common perception of disability leading to dependency, Rajesh Borle is an 'enabler'.

Seeking better employment

52-year-old **Anil Kumar** is visually impaired since the early age of two. Battling against adversities, he went to a mainstream school but had to forego his choice of Commerce due to blindness. He took up Literature instead and started his professional career as an English teacher at a private coaching centre. With a desire to earn more, he explored the option of translating books and articles from English to Malayalam. He contacted the Eyeway Helpdesk in Kochi, to help him explore lucrative job opportunities as a translator. Our counselor researched online and spoke to a few publications. As a result, Anil got a full time job at a publication house based in Coimbatore, along with a few freelance translation projects with another leading company.



Opening the doors to employment opportunity



Chandrakanta Kumari, a 24-year-old resident of Gaya, Bihar grew up in economic crisis along with two blind brothers. After her schooling, she completed graduation in B.Sc Chemistry despite several hardships. She'd given up all hope of finding employment until she found Eyeway's helpline number one day. Our counselor advised her to learn to use assistive technology like a smartphone and a smart cane, in order to move around independently. She was also encouraged to enroll in a computer training program and simultaneously prepare for competitive exams. Chandrakanta cleared her banking exam and is employed as a clerk at the Bihar Co-operative Bank in Begusarai. She happily shared with us that the bank officials are supportive and are willing to provide her basic skills training for the job.

Creating impact through a collective platform for advocacy

One of the key functions performed by Eyeway is advocating for the visually impaired where rights are denied and people are discriminated against on grounds of blindness. With Eyeway transforming into a network of organizations, we will have greater impetus to voice our issues and bring about a change. As a network, Eyeway can take up cases and launch collective campaigns with a view to impact policy. In the past year as well, there were several such cases handled by the Helpdesk, a few of which are shared below.

From victim to crusader



Blind by birth, 20-year-old **Pramod Kumar** and his sisters went to a special school in Tiloi, Uttar Pradesh, where they were regularly subjected to verbal abuse. Pramod decided to move to another institution, but he had to bribe the school to release his Transfer Certificate (TC). When his sisters Gudiya and Priyanka faced the same plight, he called the Eyeway Helpdesk seeking an intervention to voice their rights. The Eyeway team contacted the Basic Shiksha Adhikari (BSA) who put us in touch with the Block Education Officer (BEO). The BEO took up the complaint and visited the school to resolve the matter. When the school turned out to be an unregistered entity unable to issue a TC, BSA informed that up to Class 8, students could apply to any school on the basis of their Aadhar card. This helped Gudiya and Priyanka get admission in another

school. Our advocacy initiative not only helped resolve the problem at hand but also empowered Pramod to fight for the rights of many other students in his district. He filed collective complaints with the authorities on their behalf and managed to secure justice.

Assistive technology for ease of work

Dhavan Umredkar, a 47-year-old from Nagpur, Maharashtra was employed in one of the departments under the Central Government in 1996. Ten years later, loss of vision made work very difficult for him. On reading an article about assistive technology offering independence to visually impaired people, he called Eyeway for help. We gave all the necessary information about several useful devices and encouraged Dhavan to get proper training. He also inquired on how he could convince his employers to make adjustments at this work place. The counselor shared Department of Personnel Training (DoPT) guidelines, emphasizing on the department's obligation to make the office environment accessible as per the rules. With help from Eyeway, Dhavan submitted an application to his manager demanding his rights as a person with disability. His request was sanctioned.

Potential must be backed!



Indrajeet Kashyap's vision turned blurry all of a sudden one day. Soon after, his parents passed away and his siblings discarded him. A friend helped him enrol for open schooling to finish Class X. When he couldn't read the printed textbooks, he reached out to Eyeway. We shared audio book resources with him and offered much needed emotional support. Our counselor also encouraged him to seek admission in a mainstream school and promised to extend all support. When he was denied admission on grounds of blindness, Eyeway asked the Department of Education and the State Commissioner for

Persons with Disabilities to intervene. Next, we also sought financial help from individuals to cover Indrajit's academic expenses. Presently in school, Indrajeet dreams of studying further and making it big on his own.

There are many young aspirants like him who lose out on opportunities because no one believes in their potential. But Eyeway inspires them to focus on what they 'can' rather than dwelling on what they 'cannot'.

TRAINING AND CAPACITY BUILDING

To ensure consistency across the board in our response to the callers, we conduct training and capacity building sessions through the year for our counsellors. In the past year too, following programmes were designed and executed for upskilling.

Field visit to Kochi, June 18, 2019

Director- Programs & Communications, Shruti Pushkarna visited the Eyeway Helpdesk at Little Flower Hospital (LFH) as part of periodic monitoring and training exercise. She conducted an advanced documentation training, instructing new techniques to improve writing, comprehension and presentation of case stories from the state. The visit also included fruitful interactions with the LFH management on strategies to improve the performance and impact of the Eyeway Helpdesk in Kerala.



Field visit to HELP Foundation, Srinagar, July 1-2, 2019

Shruti Pushkarna and George Abraham visited the Eyeway Helpdesk partner in Srinagar to explore ideas for collaborative campaigns to benefit persons with vision impairment and sensitize the society to promote inclusion. A training session on soft skills, effective call handling and documentation was also conducted for the Eyeway counselor manning the helpline in Srinagar.



Field visit to Enable India, Bangalore, July 26, 2019

Shruti Pushkarna visited the Eyeway partner in Karnataka to conduct a comprehensive communication and call handling training workshop with the two counselors responding to queries at Enable India. Shruti also met with the senior management to discuss collaborative campaigns and promotional strategies to reach a wider audience in the state.



Field visit to Victoria Memorial School for Blind (VMSB), Mumbai, July 29, 2019

George Abraham visited the Eyeway partner in Maharashtra to review the progress and challenges specific to the helpline. He interacted with the two counselors to discuss complex cases, different ways of helping the clients and improving the response rate along with the quality of the helpline in the state.



All Counsellors' Training, Sept 26-27, 2019

The two-day Annual All Counsellors' training took place at the YMCA in Delhi. Helpdesk counsellors from Delhi, Mumbai, Bangalore, Kochi and Ahmedabad participated in the programme. The two-day training was aimed at a re-orientation of Eyeway's vision and mission, reviewing communication and documentation work and inputs on call handling by an external specialist in counseling, Dr Arvinder Singh. The training focused on the critical need for counsellors to stimulate the aspirations of the callers and how Eyeway could take the caller from being a liability to becoming a potential resource. The face to face interactions, live demonstrations of better call handling and practical writing exercises left the entire team enriched with new inputs.

Field visit to Mumbai, December, 16-17, 2019

Shruti Pushkarna visited the Eyeway Helpdesk at Victoria Memorial School for the Blind in Mumbai to monitor and evaluate the performance of the helpline in Maharashtra. Shruti also conducted a need-based training on call handling, documenting calls in respective categories and generation of effective case stories. A meeting with the VMSB management was also held during the two-day visit to iron out operational challenges.



New counsellors' training @ Score Foundation, Jan 30- 31, 2020

A two-day training program was conducted to orient a new counselor to operate from National Association for the Blind, Delhi. Tarh Aman was oriented on the Eyeway Helpdesk operation, documentation and soft skills to handle calls from northern region.

EXPLORING NEW PARTNERSHIPS

In January 2020, George Abraham visited two states to explore avenues for partnerships to expand the Eyeway network and new models of information dissemination on visual impairment. In Kolkata, George met with the management of Ramakrishna Mission Ashram and the Blind People's Association to see if a helpline could be initiated at one of these institutions. He also visited a Jaipur based NGO, Rajasthan Netraheen Kalyan Sangh (RNKS) where keen interest for a helpline was expressed in the first meeting. Unfortunately, due to a change in management at RNKS, the discussions couldn't be taken forward.

REACHING OUT

With our objective of inspiring and empowering persons with vision impairment, we curate information that can be used to raise awareness within the blind population as well as sensitize civil society at large. Our communication is targeted towards all our stakeholders which include, blind people, their family and friends; ophthalmologists and rehabilitation professionals; mass media; the judiciary; students, government and civil society.

With the Eyeway network building up, this opens up an opportunity to create a collective communications platform to disseminate information through multiple channels. Apart from using our helpline to disseminate relevant information to our beneficiaries, we engage with stakeholders through events, workshops, forums etc. We also engage with the larger society through periodic articles published on digital media to alter their mindsets and expand their imagination.

WORKSHOPS AND ENGAGEMENTS

Visits @ Score Foundation

May 8, 2019

Multinational accounting firm KPMG India representatives visited Score Foundation to discuss the scope of hiring visually impaired people and on ways to provide an accessible working environment for them.

May 30, 2019

Premier Pas, a French student association working towards changing the perspective on disability visited Score Foundation to know more about our work and activities. They produced a video interview with CEO George Abraham to bring out the highlights of our initiative.



October 11, 2019

Dr TK Bansal, a retired blind IIT professor visited Score Foundation to discuss and collaborate on his initiative of digitizing NCERT textbooks on Math, Science and Physics for ease of access to students with vision impairment. He sought our help to connect with various schools and form a group of teachers that can be trained in inclusive teaching methods.

Employment & Digital Accessibility Conference for the Disabled, May 31, 2019

George Abraham moderated a panel discussion on the 'Prospect of employment for the visually impaired in ICT enabled jobs', organized by Eyeway Helpdesk partner, National Association for the Blind. The conference was aimed to initiate a dialogue between corporates, NGOs and persons with disabilities to promote employment and digital accessibility.



Round Table Conference on Midlife Blindness Crisis, June 28, 2019

Score organized a roundtable conference in New Delhi to raise awareness about the challenges faced by people who acquire blindness at a later stage in life. The participants included NGOs working in the domain, ophthalmologists, government bodies responsible for skill development of persons with disabilities, individuals with late blindness, lawyers and so on. The discussions focused on identifying resources, provisions and opportunities available to

reorient, train and include persons with late blindness back into the mainstream society. As a positive outcome of this event, two of the late blind attendees found suitable jobs to restart their lives. National Roundtable on Disability @ India Islamic Center, New Delhi, September 6, 2019

Shruti Pushkarna represented Score in a national level discourse on disability issues, organized by VANI, an apex body of Voluntary Development Organizations. She participated in the discussions on mainstreaming disability within developmental organizations. The interactions helped other representatives from NGOs with limited understanding of accessibility and inclusion, understand ways to cultivate a climate to promote opportunities for people with disabilities.



Outreach session @ NAB Mumbai Nov 22, 2019

Maharashtra Helpdesk counselor, Darshana Jain presented Eyeway's work to the special education trainees at National Association for the Blind in Mumbai. The session was conducted by Victoria Memorial School for the Blind as a part of their outreach programme.

National Job Fair and Ability Expo @New Delhi, December 2

Score Foundation was included in the core group with other representatives from National Skill Development Corporation (NSDC), IDEA, SCPwD, Media SSC, Saksham, CBM, NCPEDP, MSJE/DEPwD/ NHFDC/ National Institutions, Navjyoti, We Are Your Voice, Sarthak, NABET, Delhi University and Atpar to give overall direction to a national job fair organised in Delhi for persons with disabilities. In November, George was also called to conduct a training session with a group of 20 call center executives responsible for registering disabled candidates for the National Job Fair and Ability Expo. The training involved sensitizing of the executives and equipping them with the right knowledge and understanding of the call handling process. The Score team also set up a stall at Divya Kaushal exhibit to disseminate information about the Eyeway Helpdesk.



Outreach programme @ Pune Blind School, 10 December 2019

Score Foundation conducted a workshop with adult blind boys and girls of Pune Blind School on the proficiency of technology and language to become successful professionals along with Victoria Memorial School for the Blind. George urged the students to master all forms of technology that would be crucial for them to become employable in the future.

CEO'S ENGAGEMENTS

Engagement with Ophthalmologists

Lady Hardinge Hospital, Delhi, August 6, 2019

George Abraham and Shruti Pushkarna engaged with medical students and teachers of the ophthalmology department at the Lady Hardinge Hospital in Delhi. The primary aim was to raise awareness among participants, which would in turn help them in responding appropriately to patients whose eyesight was beyond repair.



Shroff Charity Eye Hospital, Delhi, August 12, 2019

George Abraham was invited to a knowledge and experience sharing session by Dr Umang Mathur, Medical Director of Shroff Charity Eye Hospital. The session was a follow up from the round table conference on midlife blindness organized by Score in June. With several other prominent people from the domain, the session inspired the hospital staff and doctors to equip themselves with better response mechanisms and be open to hiring visually impaired persons into their workforce.

Engagement with Students and Youth Groups

Delhi School of Social Work, 11 April 2019

Addressed a gathering of post graduate and research students, discussing various challenges faced by persons with disabilities and the need to make them independent through employment and entrepreneurship.

Orientation for Special Education students and trainees, 17 September 2019

Interacted with 28 trainees of B. Ed (Special Education-Vision Impairment) at the Durgabhai Deshmukh College of Special Education, Delhi University, sensitizing them to the needs of their specially-abled students. George emphasized on the need to empower them to become part of the human resource of the country.



'Disability and Youth Dialogues' @ St Stephen's College, 24 October 2019

Interacted with 60 abled and differently-abled students of St Stephen's College of Delhi University in a talk titled 'Disability and Youth Dialogue' along with Nipun Malhotra, Founder of Nipman Foundation

Ashoka University students @ Score Foundation, 21 February 2020

Interacted with faculty and students of Ashoka University to help them understand various aspects of living life with blindness and Project Eyeway's work with visually impaired people.



Engagement with religious groups

Book release @ Nagpur, 4 April 2019

George Abraham was invited to a book release by Engage Disability, a fellowship of organizations, churches and individuals working to reduce exclusion of persons with disabilities from Christian communities, and to empower persons with disabilities to take their rightful place in society. The book includes a Foreword written by George.

National Conference @ Catholic Health Association of India (CHAI), 29 August 2019

George was invited by the Catholic Health Association of India (CHAI) for their national conference in Hyderabad. His feedback was requested on the research findings conducted by CHAI on the gaps in facilities and services available for persons with disabilities in the country.



Regional Conference @ Engage Disability India, 23 October 2019

George was invited as a speaker to Engage Disability's regional conference in Mumbai. A collaborative effort by churches, the event was aimed at building inclusive and accessible churches to involve people with disabilities as equal members of the church. George emphasized on making places of worship accessible to persons with disabilities and exhibiting sensitivity and empathy towards them.

Engagement with Corporates

Session @ Cipla Foundation, Mumbai 30 July 2019

George was invited by Cipla Foundation, a leading global pharmaceutical company to sensitize their CSR team on vision impairment. He apprised them of Project Eyeway's work. Cipla has been supporting the Eyeway Helpdesk operations in Mumbai since 2017.

Engagement with judiciary and government

Sensitization Session in Srinagar, July 1, 2019

George Abraham was invited to speak to a group of judges, nodal officers and people working with disability organizations in Jammu and Kashmir to raise the awareness levels of the participants so they could help in creating better access to all infrastructure and services for persons with disabilities in the state.



Meeting with the Department of Law- Delhi Government, 27 January, 2020

As an appointed member of the committee set up by the Delhi Government's Department of Law, George was invited to give his inputs on the new jobs identified for persons with disabilities. He stressed on the need to invest in aids, appliances and technologies for visually impaired people who could be appointed in the positions available within the department. George spoke to the group about vision impairment, sharing his life journey to inspire them to look beyond the disability and bring out their abilities.

The seven-episode show series was a part of The Hans Foundation's public awareness campaign on Disability with the India Today Network. Sharing the stage with renowned Indian film actor, Naseeruddin Shah, George spoke about his journey, his contribution to the Blind Cricket Association and Eyeway.

AIR special show on White Cane Day, October 15

George Abraham was invited by All India Radio on International White Cane Day to moderate a discussion titled 'White Cane, showing the way to the world'. The show focused on how blind persons can lead a successful life using assistive technology. Experts featuring on the radio show were Praveen Kumar, Social Inclusion Advisor at VSO, Monica Sharma from Concentrix, Prashant Verma, General Secretary of NAB Delhi.



Airtel Delhi Half Marathon, 20 October, 2019

George participated in the Airtel Delhi Half Marathon 2019, running 10 kms to raise INR 10 lakhs for Project Eyeway. Accompanied by his family, he completed the run in 1.5 hours. We are grateful to all those who donated to us and a special thanks to our supporters, APS Bhalla and Rajender Sud who also ran the marathon to raise funds for our work with the blind.

Drive value through Disability Inclusion, Nov 29, 2019

George was invited to the 'The Valuable 500' organized by The Confederation of Indian Industry (CII) - India Business and Disability (IBDN) and Brookfield Properties in association with EnAble India. Founded by Caroline Casey, 'The Valuable 500' is a global campaign launched at the World Economic Forum in 2019. It aims to bring together 500 CEOs across the globe with a commitment to get disability inclusion on the agenda of the boardroom roundtable 'Drive Value Through Disability Inclusion'.

Round Table Consultation International Day of Persons with Disability, 03 December, 2019

In commemoration of the International Day of Persons with Disabilities, George was invited as a speaker to the discussion organized by Rajeev Gandhi Foundation on 'Challenges, Policies and Programmes to provide Opportunities for Persons with Disability'. As a Disability Activist, George spoke about the need to look at people with disabilities as a potential resource to be invested in rather than a liability, to be merely provided for.

George, on the basis of his extensive experience in the disability domain, is a member of the governing body of SCPwD. The primary role of this body is to identify challenges and opportunities across various sectors for Persons with Disability. During the year, George participated in two of their meetings where he suggested that along with imparting education and training, sensitizing potential employers on hiring persons with disabilities is critical for a meaningful employer-employee engagement.

The Eyeway website is a comprehensive repository of information and knowledge on living life with blindness. It plays a key role in information dissemination. It is regularly updated and populated with content like job updates, news updates, informative blogs, inspirational stories, videos and a whole range of resources and FAQs on topics such as employment, education, legislative provisions, public services and infrastructure, assistive devices and technology, understanding your eye condition and so on. The website functions as a window to information on different spheres of living life with blindness.

Some of the articles written by George Abraham and Shruti Pushkarna on mainstream media platforms were republished on the Eyeway website to reach a wider audience, especially those with vision impairment.

George wrote about how sports broadcasters overlook blind cricket fans and urged to draw up a set of guidelines to ensure the coverage becomes more inclusive. He also drew attention to the inaccessibility of online banking for visually impaired people through an opinion piece in Hindustan Times.

Shruti through a series of articles raised awareness about the various challenges faced by blind and visually impaired people, encouraging mainstream media to report on disability related issues to sensitize the civil society.

The number of page views reported on our website from April 2019 to March 2020 is **438486**.

THE ROAD AHEAD

All our efforts are directed towards filling the information and resources gap that exists in India vis-à-vis blind population. At the end of the day, every blind person residing in any corner of the country should have a number to call, so they can access solutions close to home. In our dream to successfully integrate visually impaired people into the mainstream, a lot of ground still remains to be covered.

In the past months following the Covid outbreak, we've witnessed conventional solutions become irrelevant. Eyeway has redirected several callers to training programmes and workshops which have now ceased to function in their usual physical setups. Activities and solutions have moved online. But the good news is that Eyeway has always encouraged visually impaired people to use technological aids and innovations to participate in the mainstream. With education and employment shifting to a virtual space, a lot of barriers have come down for blind people.

In the coming year, we want to promote digital literacy, encourage and collaborate with fellow NGOs to create model states of inclusion. Given the huge hit suffered by the conventional job market, we also want to launch a self-employment training programme for blind people.

As for the helpline, we will continue strengthening our network, consolidating resources and improving the callers' overall engagement with our counsellors stationed across India.
